## GRI requirements must be completed within five years.

Michigan REALTORS® enrolled in the program must complete the following designation requirements within a five year time frame. This time frame is on a rolling scale which means that courses will expire after five years and will need to be retaken.

- Provide a GRI lapel pin to help other identify your accomplishment and training.\*
- Provide you with a GRI personal promotional packet which will include a verification letter, press release and GRI/REALTOR® logo information.\*

\*Please allow 4-6 weeks for delivery.

**Please Note:** Unlike other designations, you do not have to join a chapter or pay yearly dues to use your GRI designation. Once you have been notified that you have been awarded the GRI designation, all you must do to hold and use the designation is maintain your membership in the REALTOR® organization.
